



**ARTICLES OF AMENDMENT
Amendment # 1
Project Number: 2018-ON-006**

These Articles of Amendment are made between Her Majesty the Queen in right of Canada (referred to in these Articles of Amendment as the "Crown"), as represented by the Minister for International Trade (referred to in these Articles of Amendment as the "Department") and:

(Hereinafter referred to as the "Recipient" and jointly as the "Parties")

The Department and the Recipient agree to amend the Contribution Agreement made as of **March 6, 2018**, as follows:

1. Paragraph 2(1) & 2(2), Page 3 of the Contribution Agreement will be deleted and replaced by:

2. THE CONTRIBUTION

(1) Subject to the terms and conditions of this Contribution Agreement, and unless otherwise noted, the Department shall contribute to the Recipient up to 50% of the Eligible Costs of the Project incurred during the Project Period up to a maximum of:

CAD \$428,062.50

(2) The Contribution of up to **CAD \$428,062.50** is based upon the total Eligible Cost of the Project being a minimum of **CAD \$856,125.00**. If it is subsequently determined by the Department that the total Eligible Costs of the Project are of a lesser value than the original figure, pursuant to Schedule 1, then the Recipient shall be required to refund to the Receiver General for Canada, via the Department, a prorated amount in relation to the Department's portion of the Project costs against the total Eligible Costs of the Project, unless those total Eligible Costs of the Project have been previously adjusted and approved in writing by the authorized signatory of the Department, pursuant to section 14 of this Contribution Agreement.

4. SCHEDULE 1(B) and 1(C), Page 17 of the Contribution Agreement will be deleted and replaced by:
